DESCRIPTION OF KNOWLEDGE (KNOW) LEVEL OF NURSES ABOUT CLINICAL PATHWAYS DOCUMENTATION IN CATHOLIC HOSPITALS BUDI RAHAYU BLITAR

The implementation of clinical pathways in Indonesia has also been mandatory since accreditation for hospitals based on the accreditation standards of the Hospital Accreditation Committee version 2012 as an effort to create good clinical governance. The phenomenon obtained by Clinical Nurses II and III researchers has not completed complete clinical pathways documents in accordance with hospital accreditation standards. The low documentation of filling out the clinical pathways sheet was found to be 30% during 2023 where the percentage of incompleteness of the clinical pathway form should be 0%. The purpose of this study is to identify the level of knowledge (know) of nurses about the documentation of clinical pathways at Budi Rahayu Catholic Hospital Blitar. The research design used was descriptive with a total of 42 respondents using the purposive sampling technique. Research variables of nurses' knowledge about clinical pathways documentation. The research instrument used a questionnaire sheet. The results of the study showed that most of the respondents' knowledge level about clinical pathways documentation was 73.8% had good knowledge. The results of the study found that information sources and socialization greatly influenced the level of knowledge of nurses. The author provides advice to nurses to increase compliance, responsibility and motivation in the documentation of clinical pathways in accordance with PNPK information sources.

ABSTRAK

GAMBARAN TINGKAT PENGETAHUAN (TAHU) PERAWAT TENTANG DOKUMENTASI *Clinical Pathways* DI RUMAH SAKIT KATOLIK BUDI RAHAYU BLITAR

Implementasi *clinical pathways* di Indonesia juga sudah diwajibkan sejak akreditasi bagi rumah sakit berdasarkan standar akreditasi Komite Akreditasi Rumah Sakit versi 2012 sebagai upaya menciptakan *good clinical governance*. Fenomena yang didapatkan peneliti Perawat Klinis II dan III belum melengkapi dokumen *clinical pathways* secara lengkap sesuai dengan standar akreditasi rumah sakit. Rendahnya dokumentasi pengisian lembar *clinical pathways* ditemukan 30% selama tahun 2023 dimana seharusnya persentase ketidaklengkapan formulir *clinical pathway* adalah 0%. Tujuan penelitian ini untuk mengidentifikasi tingkat pengetahuan (tahu) perawat tentang dokumentasi *clinical pathways* di Rumah Sakit Katolik Budi Rahayu Blitar. Desain penelitian yang digunakan deskriptif dengan jumlah 42 responden dengan teknik *purposive sampling*. Variabel penelitian pengetahuan perawat tentang dokumentasi *clinical pathways*. Instrumen penelitian menggunakan lembar kuesioner. Hasil penelitian sebagian besar tingkat pengetahuan responden tentang dokumentasi *clinical pathways* 73,8 % mempunyai pengetahuan baik. Hasil penelitian didapatkan bahwa sumber informasi dan sosialisasi sangat berpengaruh terhadap tingkat pengetahuan perawat. Penulis memberikan saran kepada perawat untuk meningkatkan kepatuhan, tanggung jawab dan motivasi dalam dokumentasi *clinical pathways* sesuai dengan sumber informasi PNPK.
